1. **John Belconger** was born on 8 Sep 1633 in Suffolk, England. He was christened on 8 Sep 1633 in Great Yarmouth, England. He died about 27 Aug 1712 at the age of 78 in Woodbridge, Middlesex Co., NJ. John was buried about Sep 1712 in Woodbridge, Middlesex Co., NJ. He has Ancestral File Number 4KJ0-QQ. John Belconger

COMMENT: Ancestral File shows, John Belconger (Conger); b. 8 Sep 1633, Yarmouth, Norfolk, England, Great Britain; d. 27 Aug 1712, Woodbridge, Mddlsx, [sic], NJ; Christening, 8 Sep 1633, Great Yarmouth, England

AKA: John Conger; John Conger "primus" by Charles G.B. Conger. What does "primus" in italics mean?

BIRTH: Abt. 1633 in England, perhaps in Norfolk County. Other dates of birth of 1640 and 1641 have also been listed. In CFAII, Maxine Leonard disputes the date of Abt. 1633.

QUESTION: Can anyone cite a source for the birth date?

MARRIAGE: "A Mary Kelly, m. April 12, 1666, John Belconger. She may have been a dau. of John."

BIOGRAPHY:

John Belconger came to Newbury, Massachusetts from England in 1665. He and his first wife, Mary Kelly, had first two children in Newbury and then moved to Woodbridge, New Jersey in 1667 or 1668. Shortly after moving to Woodbridge he shortened his name to Conger. He was illiterate and always signed his name with an "X".

It has been reported by some researchers that John (Belconger) Conger is the ancestor of all Congers in America. They also report that the name, Conger, does not exist in present-day England and that the name, Belconger, is very rare, existing only in County Norfolk.

BIOGRAPHY:

In 1665, John Conger came from England to Newbury, Mass. On Jan. 12, 1666 he married Mary Kelley, b. in Newbury, Feb. 12, 1641, the only daughter of John Kelley.

John Kelley came from Newbury, England to Old Newbury, Mass. with the original founders of the town in 1635. His only other child was a son, John Jr., who married Sarah Knight, the daughter of Deacon Richard Knight. John Jr. and Sarah had five children who had numerous descendants.

The Kelley Ferry operated for many years by father and son was a popular mode of travel in the early days of Newbury.

Daniel Pierce, a prominent citizen, well known throughout Mass. colony was organizing a group of citizens to move to a newly acquired Province of New Jersey which King Charles had wrested from the Dutch in 1664. In 1667, Pierce with nine associate owners and forty-six other men, many with families, arrived in New Jersey and founded the township of Woodbridge, located on an estuary that flows between Staten Island and the mainland and between Rariton and Rahway Rivers. Woodbridge, traditions says, was named for the Presbyterian minister they left back in the Newbury home.

John Conger and his wife, Mary, and their infant son were among this company. Tradition is, and can be proved by some facts, that the Conger family came from Alsace, then a French province, to Holland (the name being Koeniger about the date of the massacre of St. Bartholomew 1572), and then from Holland to England, the name being anglicized into the English, Conger.

He left a will, dated 11 Jan 1711, proven before Thomas Gordon on 27 Aug 1711, approved and sealed by Col. Hunter on 17 Oct 1712.

PROBATE: Will of John Conger, 11 Jan 1711

In the name of God, Amen, the 11th day of January 1711. I JOHN CONGER of Woodbridge, in the county of Middlesex, and Province of East New Jersey, Planter, being in bodily health and in perfect mind and memory, thanks be given to God, therefore: Calling in mind the mortality of this body, and knowing that it is appointed for all men once to die, do make and ordain this my last will and Testament, that is to say, principally and first of all, I give and recommend my soul into the hands of God that gave it, and for my body I recommend it to the earth, to be buried in a Christian-like and decent manner, at the discretion of my Executors, nothing doubting but at the general Resurrection I shall receive the same again by the mighty power of God, to bless me in touching such worldly estate, wherewith it has pleased God to bless me in this life. I give, devise, and dispose of the same in the follow manner and form:

ITEM: My will is that my farm or plantation on which I now dwell to be equally divided into two parts, beginning at the River and running with a direct line through the whole length of my said farm or plantation, the Eastern division whereof I will and bequeath to my son BENJAMIN CONGER, to be by him quietly and peaceably possessed, and enjoyed as soon as he shall arrive at the age of 21 years, and if my son JOSEPH please, he shall have the liberty to live upon it 10 years after my decease, paying the charge arising thereon.

ITEM: The use and improvement of the western division of my said farm or plantation, and my dwelling house standing thereon I give to my wife during her state of widowhood and when her condition shall change either by marriage or death I will and bequeath the said western division of my farm together with my now dwelling house and all other buildings thereon to my son JOB CONGER.

ITEM: I will and bequeath to my son JOSEPH all my freehold right in the towne of Woodbridge (Will also specifies as conveyed to Joseph his rights to Woodbridge common lands yet to be divided.) I give to my son my Carts and Ploughs with all the tackling belonging to them to my son JOSEPH to have liberty to use them when they can be spared so long as he lives upon the place, he being at equal charge at repairing them.

ITEM: My will is that if either of my three sons above mentioned, JOSEPH, JOB or BENJAMIN, shall die without issue, then what land I have willed to them do descend to the survivor or survivors, and be equally divided between them.

ITEM: I give to my son JOHN ten schillings; to my son JONATHAN five schillings; to my son GERSHOM five schillings; and to each of my daughters five schillings, all to be paid by my son JOB, if demanded.

Lastly, I give all my cattle, horses, sheep and household stuff, to my faithful and beloved wife, SARAH CONGER, whom I do nominate and appoint my sole Executrix, to see that this, my last will, be punctually fulfilled, and I do declare this to be my last Will and Testament, hereby revoking and making void all other wills by me formerly made. In witness whereof I have hereunto set my hand and seal, the day and year above written.

CODICIL: June 14, I the above name John Conger, being very sick in body and not expecting many hours of this life, and my son GERSHOM being born since the making of this my Will, above written, do declare that my will & desire is that my three sons, JOSEPH, JOB and BENJAMIN, as they come to age, give unto my son GERSHOM, ten schillings, each of them and that seven pounds out of my movable estate be put out for his use when he comes to age, this I declare to be my desire before these witnesses.

CONFLICT: Codicil Confusion

The naming of a youngest son, Gershom Conger, in the Codicil has caused confusion and conjecture among Conger researchers, owing to the fact that an elder son of John Conger, named Gershom who had been born in 1685, was listed in the last "ITEM" of the 11 Jan 1711 will. At the time the will was written, the elder Gershom was married and was father of David, born in 1707 and Phoebe, born in 1708.

Researcher, Charles L. Conger, believed that the Gershom Conger, born in 1711, was the son of Gershom Conger, born in 1685. Gershom Conger, b. 1685, supposedly died before his father, a date of death of, Abt. 1710/1711 in Union Co., NJ, has been listed by some researchers.

It seems highly unlikely that John Conger would have had a son in 1711. At that time, his health was probably already failing, since he had drawn up a will. And, his second wife, Sarah Cawood, who had been born in 1660, would have been 51 years old.

It seems more reasonable that either the person drawing up the Codicil made a mistake when he wrote, "... my son Gershom being born since the making of this my Will..." or that John Conger was confused in his last days, and that the family pampered him in his belief that his grandson was indeed his son. If the Gershom, mentioned in the Codicil, was indeed the grandson of John Conger this would raise the question of why this grandchild was the only one that John Conger chose to mention, by name, in his will.

suggested birth date of 12 Feb 1641 at Newbury, Essex, MA. Apparently she had a sister, Sarah, whose birth date has been listed as, 12 Feb 1640 and as 12 Feb 1641. Some have suggested Mary and Sarah were the same person. In 1984, Noreen Pramberg of Newburyport, MA wrote, "it is a pretty well accepted notion that Sarah and Mary Kelly were two different people. Sarah married Thomas Burkbee of Rowley, 15 Apr 1659; and Mary married John Belconger." [Note: No source citation for the Burkbee marriage record. REH] On page, 16 of CFAII, Maxine Leonard wrote, "The birthdate we have for Mary in the CFA was actually that of Sarah Kelly."

The 29th day of November, in the year of our Lord one thousand seven hundred thirty-five, I, Gershom Conger, Junr of Woodbridge, in the county of Middlesex, in the Province of New Jersey, carpenter, being very sick in body but of perfect mind and memory, thanks be given unto God, therefore calling unto mind the mortality of my body, and knowing that it is appointed for all men once to die, do make and ordain this my last will and testament.

That is to say, principlly and first of all, I give and recomment my soul unto the hands of God, that gave it. And for my body I recomment it to the earth, to be buried in a Christianlike and decent manner, at the

discretion of my executors, nothing doubting that in the general resurrection, I shall receive the same again by the mighty power of God. And as touching such wordly estate, wherewith it hath pleased God to bless me with in this life, I give, devise, and dispose of the same in the following matter, and form.

Impremis: It is my will, and I do order that in the first place, all of my just debts and funeral charges be paid and satisfied.

ITEM: I will and bequeath to my dearly beloved Couzen Gershom Cawood, thirty-six pounds current money, at eight shillings to the ounce, to him and his heirs forever, to be put out to interest to the best advantage which is upon bond, and my will is, that my executors do sell five cows and their produce the next spring after date hereof, and put the money arising therefrom to the best advantage, to the sole use of my said Couzen Gershom Cawood, and his heirs until he shall arrive to the age of twenty-one years.

ITEM: I give and bequeath unto my loving brother Thomas Cawood, his heirs and assigns, one yearling bull, and one mare. I also appoint Thomas Cawood, my whole and sole executor of this my last will and testament.

ITEM: I give and bequeath to my loving brother Robert Mitchell, one cow to him, his heirs and assigns. It is my will, and I do order my executor to sell my tools to enable him the better to pay my debts.

And I do hereby utterly disallow, revoke and disannul all any other former Testaments, Wills, Legacies and Executors, by me in any way before this time named, and willed and bequeathed, ratifying and confirming this and no other, to be my last will and Testament, in witness whereof, I have hereunto set my hand and seal, this day and the year above written. GERSHOM CONGER (L.S.)

WILL-PROBLEM: The will of Gershom Conger, b. 1711, is equally confusing [as the will of John Conger written 11 Jan 1711]. He died at the age of 25, unmarried. He speaks of his cousin, Gershom Cawood -- which would be correct if his mother was a Cawood and had a brother with children. He referred to himself as "Gershom, Junr," indicating his father was, Gershom, yet if named for a brother he was probably called, "Junior."

COMMENT:

Gershom Conger has been the most controversial figure in the Conger history.

This Gershom Conger was born between the time John (Primus) [Belconger] made his will on 11 Jan 1710 and the addition of the codicil to the will on 14 Jun 1712, in which codicil provision is made "for his son Gershom, who had been born since the dating of the will."

The naming of this youngest son, Gershom, has caused more or less confusion and conjecture, owing to the fact that the elder son, Gershom, was named in the will of John [Bel]Conger, primus, dated 11 Jan 1710. At this time, the elder son, Gershom, was married and was the father of, David, born 1707 [and] Phebe, born 1708. [Researcher] Charles L. Conger places this Gershom, b. 1711, as the son of Gershom, b. 1685. This seems to be the most accurate identification for several reasons.

The elder Gershom, b. 1685, died before his father, although no death date is given. If John was the father of a son born [in] 1711, this is probably why he named him after the son he lost.

It seems more reasonable to believe that John may have been having hallucinations in his last days -- and

that the family pampered him in his belief that his grandson was indeed his son. The codicil reads, "being very sick in body and not expecting many hours in this life," -- and nothing about being "sound in mind."

John's first wife, Mary Kelly, was born in 1641; she and John were married in 1666, so John was probably born around 1640. It is possible, but not probable, that he had fathered a child during his ill health at the age of 70 or older.

The will of Gershom Conger, Junr, was witnessed by James Wilkison, who was probably a son of either, John, Edward, or Allen Wilkison, who were grandsons of John & Mary Kelly [Bel]Conger.

Gershom refers to himself as "Gershom Conger, Junr" [in the will], so his father would have [probably] had the name, Gershom. His "loving brother Thomas Cawood," could have been his brother-in-law, husband of his sister, Phoebe. Perhaps his "loving brother Robert Mitchell," was married to an unidentified sister.

Maxine Leonard was inclined to side with Charles L. Conger in placing this Gershom as the son of Gershom Conger, b. 1685, [the son of John Belconger].

CONFLICT-COMMENT:

It isn't clear from the information on page 707 of CFA II that the Abigail Conger, being discussed, was the daughter of John Belconger and Sarah Cawood.

On page 11-a of CFA I, she is listed as the first child of John and Sarah (Cawood) Belconger, being born in 1690 and married first to Mr. Brown and second to James Clarkson.

The Clarkson family group is listed on page 716 of CFA I as follows: James Clarkson, b. Abt. 1688, md. 18 Dec 1706 to Abigail Conger, b. 8 May 1690 at Woodbridge, Middlesex, NJ, dau of John Belconger & Sarah Cawood. Their first child, Agnes Clarkson was born, 5 Jun 1708 and later married John Coddington. Another, source (not cited) lists the birth date of James Clarkson as, Abt. 1 Mar 1687 at Woodbridge, Middlesex, NJ.

John Conger, Jr., born 24 May 1674 in Woodbridge, NJ was the half-brother of Abigail Conger, his parents being, John Belconger and Mary Kelly.

Therefore, it seems clear that the date, 8 May 1690, listed as the date of marriage on page 707 of CFA II is in error. This date is the birth date of Abigail Conger.

BIOGRAPHY:

Joseph Conger lived at Woodbridge, NJ for many years, and it is likely that he died there.

He is mentioned in his father's will, dated 11 Jan 1710, in which he was given his father's freehold rights, in the town of Woodbridge, and was also allowed to occupy the eastern portion of the farm for ten years after the decease of his father, and to have the use of all tools, carts, plows, etc., he being to equal in their repair as long as he lived on the place.

That portion of the land that he was allowed to live upon, had been devised to his younger brother, Benjamin, who at the time of the dating of the will, was about ten years of age, being born about 1700.

The permission given to Joseph to live on the land might indicate that he was married, in which event his wife must have been born as early as he was -- 1792 [sic, 1692]. However, Joseph Conger was mentioned in the will of John Marsh of Rahway, as being the husband of the testator's grand-daughter, Mary, which might indicate that she was rather old to have been named as grand-daughter of a man living as late as 1739, the date of the will, unless she was the second wife of Joseph Conger.

Conger said there were four unattached Congers of the period, namely, Joseph of Sherman, Conn., John of Hanover, Morris county, NJ, Elizabeth, who married John Baldwin, and James, who he listed as being children of Joseph Conger (1692). They were all born between 1714 and 1720, except that James was born about 1734, and may be the issue of the second marriage of Joseph Conger.

His reasons for assuming that they were the children of Joseph Conger is by elimination. To begin with, there is no New Jersey record of any sort showing the birth of a son or daughter to Joseph Conger, but as a result of the elimination of all known parental contenders of that time, it is assumed the four above-mentioned Congers were the children of Joseph Conger.

On 2 Nov 1712, Joseph Conger, together with a number of other freeholders of the town of Woodbridge, gave power of attorney to three of their number, viz. John Bishop, Thomas Pike and Adam Hude, to sell as much of their land as will bring forty pounds, which was to be applied to the cost of a lawsuit being carried on in the name of John Pike, in defense against paying Quit-rents (new Jersey Deeds, C-2-86).

The Middlesex county court records show that in 1714 there was a case on trial, John Brock vs. Joseph Conger. No particulars were given.

On 23 Aug 1716 there was laid out to James Clarkson, Jr., 5 acres of land in Rahway, "it being half a third division lot in Woodbridge, which the said James Clarkson purchased of Joseph Conger." (W.T.R.A.-25)

On 13 Mar 1735, Joseph Conger witnessed the will of John Moore of Woodbridge.

On 14 Mar 1737, it was voted "that the committee appointed to manage the school land shall pay to Joseph Conger the sum of four pounds and ten shillings out of the rent of the said school land, it being the sum agreed upon by Henry Freeman and Joseph Bloomfield, appointed for the purpose." And further my will and pleasure is that my beloved wife, Ann Conger, shall be comfortably supported with every necessity of life by my aforesaid two sons, equally alike in the expense, and lastly I constitute, make and ordain my well beloved son John Conger, and my treasured friend James Manning, as my only and sole executors of this my last will and testament, and I do hereby utterly dis-allow, revoke and dis-annull all and every other former testaments, wills, legacies, and executors by me in any ways before this time named. A daughter, Ruth, is listed in his will but not listed as a child in CFA I, p. 158.

RECOLLECTIONS:

Enoch Conger, son of Job and Keziah Conger, was named as executor of his father's will, and also inherited one-half of all his father's real estate. The will was dated 29 Jan 1749, but was not proved until 17 Feb 1758, at which time it is thought the youngest son, Moses, became of age. The will provided that Enoch was to have the use of the inheritance of his brother, Moses, for a period of seven years. The will further provided that neither Enoch or Moses could dispose of their inheritance until they had attained the age of thirty years.

It is thought Enoch Conger left Rahway [NJ] about 1765, or later, and removed to Nine Partners, town of Northeast, Dutchess County, New York, a place only a short distance from New Fairfield, Conn, where his cousin, Joseph Conger, was then living. From there he moved to Danby, VT before 1770.

From Williams's "History and Map of Danby, Vt," we gather the following abstract of the settlement and organization of the town. Sixty-eight persons petitioned to the governor of the Province of New Hampshire for a grant of land six miles square. On 27 Aug 1761, the petition was granted. Enoch Conger was not one of the petitioners.

Each one of the petitioners was to have an equal share and their share, or lot, was to be numbered. The company had their headquarters at Nine Partner's, Dutchess County, New York, where the drawing took place on 5 Sep 1763. Among the first settlers who came in 1765 was Joseph Earl. The annual meeting of the proprietors was held in 1766, 1767 and 1768 at Nine Partners, and after that at Danby, [VT].

The organization of the town of Danby, VT, dated from 1769, and in that year the first highways were laid out, and the second division of land was made. The first road laid out was on the land of Joseph Earl. Quite a number of the original proprietors were selling their rights to new settlers. The trouble over the "New Hampshire grants" was on, and was causing a great deal of disturbance. New Hampshire, the Province that made the grants, was exercising authority over them and this authority was disputed by the Province of New York. Hence the reading of the body of the deed, next to be mentioned.

These deed records are taken from the Danby Town Records. As Williams makes no mention of Enoch Conger. A deed dated 23 Mar 1771 and recorded 29 Apr 1775, Joseph Earl to Enoch Conger, "all undivided lands after the third division, belonging to the first division right of lot number 35". This was originally owned by William Barton, and lot number 47 by William Shaw, both of whom sold to Joseph Earl.

On 20 May 1772 Enoch Conger recorded his ear mark, which is a slit in the top of each ear of livestock. The next reference to Enoch Conger is dated 6 June 1776: "then surveyed and laid out for Enoch Conger, one fifty acre lot of land, laying on the west side of Micha Vail's third division lot. The above fifty acres belong to the right number 35, in the first division of land in said township.

First of all, I will and bequeath to my dear and well beloved wife Berzillah, all that 50 acres of land wherein she now lives, as long as she remains my widow, to have the whole of the profits thereform, arising and further, that my said widow keep her family together, as much as in her power, and convert the profits of said farm to the use of bringing up my poor orphan children until the youngest shall become to the years of maturity, or to the age of twenty and one.

Further, I do hereby constitute and appoint my two sons, Job and Enoch, after my decease, to pay all of my funeral charges, cost of doctors and nurses, and all other necessary charges accrued in this my sickness, out of such part of my estate as can be spared, out of my family so left, and further, if my said widow shall think most convenient for herself to marry after my decease, in any time before my youngest son shall be of age, that I hereby order my two sons here made executors to take all

my estate both real and personal, and forthwith have the same inventoried, and appraised according to law, and give to their mother her third. And then divide all the rest, and remainder of my estate equally with all their brothers, and making their sister Ruth equal with any of her brothers, always reserving to themselves, over and above any of the rest, sufficient to pay all my just debts. And this I make and ordain to be my last will and testament, according to the true intent and meaning, herein set forth.

Both were forbidden to dispose of their inheritance until they had reached the age of 30 years, which in the case of Moses would be about 1765. He was known to have been living upon his estate in Rahway, NJ as late as 1771.

RESIDENCES: The two older brothers of Moses Conger, Job Jr., and Enoch, removed to Dutchess county, New York and later Job removed to Albany county, New York and Enoch to Danby, Vermont, about 1770. Moses apparently remained in Middlesex county, New Jersey.

On 18 Feb 1771, the following notice appeared in the "Weekly Post Boy," #1498: "Notice is hereby given that the plantation of Moses Conger is to be sold by a public sale to the highest bidder at vendue, on the 25th day of March in the afternoon, if not sold at a private sale before.

"It is well situated for a gentleman, a tradesman or farmer, allowed good land lying in Woodbridge, Rahway Neck, adjoining that pleasant river which afford[s] fish in plenty in season, and is navigable for boats, sloops, etc.. There is a tolerable good house and barn. It is exceedingly well watered, some wood and fine orchard, and another one which is considerably older. It contains by estimation between 70 and 80 acres of upland, nearly 15 acres of Salt Marsh, as handy and as good as any in that part. Any person wanting such may apply to the subscriber before the day of the sale, who will give good title, and reasonable terms N.B., said place likes convenient for a ferry to be erected across the Rahway River to Elizabethtown.
(signed) Moses Conger."

It is not known if this was his own land he was selling, or the land of his nephew, Jonathan Coddington, of whose will he was an executor. However, the Salt Marsh is mentioned, so this may have been his land.

LEGAL_MATTER:

RECOLLECTIONS: According to a letter from Dr. Mount Johnson of Venango, Crawford county, Penn., dated 2 Feb 1911: "As the tradition went, Moses Conger and a relative unknown, left New Jersey and started west. Moses Conger had his leg broken somewhere in the mountains, between New Jersey and Wheeling, West Virginia [sic, Virginia]. Whether the relative deserted him or was killed by the Indians, Moses never knew.

"He was taken in by a Quaker family, where he remained about a year, and then floated down the Ohio River to some place in Kentucky. Of his subsequent career, nothing is known until he went with other volunteers called for by Governor Isaac Sheel, to go to Fort Washington (now Cincinnati) and from there with 'Mad' Anthony Wayne, to the battle of Fallen Timbers in August 1794.

"On his return he was favorably impressed with the lands in Mill Creek Valley in Hamilton County, Ohio, and tried to buy a quarter section of land, but did not have money enough. However, in the spring of 1795 he removed from Kentucky to Ohio, and squatted on some land there, and worked for the Ludlow family, at or near Cincinnati.

"In 1798, his wife died and was buried where not stands the First Presbyterian Church, near the corner of 4th and Main Streets. About 1841, the bodies were removed from this burial ground, and in the removal of bodies, the charts and files were lost.

"In 1804, Moses Conger removed to the Bray place near Westwood, as it is now called.

"In 1809, he died west of the great Miami River, near the present town of Harrison, Ohio, practically on the Indiana line (of milk sickness)."

Dr. Johnson referred to his great uncle, Daniel, so his grandmother must have been Ara Conger, who married John Banos. His mother died of Asiatic Cholera on 12 Jul 1850 and was buried in Banos Graveyard. She was born in 1813 and married in 1834.

[Note: Mrs. Leonard is confused about the relationship of Dr. Mount Johnson. His mother, Ara Conger, married Henry Johnson. His grandparents were: John Hendricks Conger and Nancy Grady and his great grandparents were Moses Conger and Miss Hendricks. This conclusion reached based on where Ara Conger's brother, Daniel McFarlane Conger, fits in the family tree. REH]

He mentioned visiting the widow of his mother's [note listed in CFA I, p. 378, as g/mother's] brother, Daniel McFarlane Conger, living at Peoria, Illinois and his mother's only sister, Caroline Conger Wallace, who was buried in Lincoln, Ill. When the above letter was written from Nashville, Tenn. Dr. Johnson was 76 years of age. (Source: The Conger Family of America, Vol. I, p. 378 - Maxine Crowell Leonard)
